#### **Spiritual Growth of Members**

2021

Efforts continued in 2021 to learn more about our theme 'Care For Our Common Home'
mostly through prayer and sending suggested readings via email or direct mail. One council
asked their members to clean out closets and drawers then donate coats, clothes, old
eyeglasses, books and blankets to various charities in need. Another council developed
Thanksgiving Reflections and Prayers focused on Laudato Si, specifically 'ecological
conversion'. They also reflected on 'Indigenous way of caring for our common home'.

- The % of councils spending one third of their meetings on spiritual growth has decreased but mostly because if they are meeting at all, the time is kept short due to restrictions: and the time they have is used for essential business. All meetings are still started and ended with prayer.
- For liturgies and programs, many Masses were held for living and deceased members.
  Rosaries before Mass and for Feast of Our Lady of Lourdes were prayed. Outdoor prayer
  services for National Truth and Reconciliation Day and Christians in the Holy Land were held.
  One Spiritual Advisor provides reflections on the Bible at meetings.
- Our Lady of Good Counsel was honoured through Masses and personal prayer. Some members were encouraged to pray the Litany to Our Lady of Good Counsel.
- For the newly initiated 'CWL National Faith Day' on September 19<sup>th</sup>, there were a few Masses celebrated to mark the occasion. Most councils were either limited with the restrictions or hadn't yet heard of this day. Communication will be key going forward.
- Most Spiritual Advisors attend council meetings, and they are included in the agenda. Their
  role is that of support and advisor. Some lead the participants in prayer and reflections, as
  well as answer any theological questions from members. Some provide suggested websites,
  spiritual readings as well as online conferences to attend.
- Parish Spiritual Development chairs continue to develop their own spirituality through novenas, spiritual books, daily rosaries, divine mercy recitation and bible studies. They are also inspired by attending daily Mass (in person or on TV), participating in webinars, virtual presentations, music and keeping in touch with homebound members.
- Only 35% of chairs use National resources such as Communiqués, prayer resources for ideas on services and newsletters.

# Study of Catholic Teachings and Role of Women in the Church

- Only 29% of councils encouraged members to study Catholic teachings and the role of women in the church by attending and promoting related webinars and retreats.
- 2 councils have started to study Pope Francis' encyclical Fratelli Tutti (On Fraternity and Social Friendship)
- 82% of councils reported participating in Pope Francis' ask to pray the rosary daily in May to end the COVID-19 pandemic.
- Many members took up leadership roles in their parishes such as parish committee chairpersons, pastoral councils, finance committees and diocesan councils.
- Only a few members joined their parish liturgy committee.

#### **Evangelization and Mission Assistance**

- Some councils were able to participate in the CWL Day of Prayer for Home Missions through organized rosaries and special prayers given to members to recite.
- Councils supported the Catholic Missions in Canada (CMIC) through financial donations. They also purchased the CMIC calendars and made them available to parishioners

#### **Lay Ministries**

- Many standing committee chairs were personally involved in parish lay ministry with most serving as lectors, hospitality, ushers and choir ministry.
- The same can be said of our members while also being involved in Eucharistic Ministry, decorating and parish sacristans.
- Several of these ministries are chaired or organized by CWL members

#### **Ecumenism and Interfaith Endeavors**

- Very few council were able to reach out to women of other denominations and faiths by initiating joint prayers services or inviting them to council meetings and other events
- Councils did promote ecumenical events by participating in the World Day of Prayer, the Week of Prayer for Christian Unity and Women's Inter-church Council of Canada
- For Orange Shirt Day Celebration, one council used the Prayer Service developed by Colleen Martin, Thunder Bay Diocese, with great success.

#### **Spiritual Development Training and Support**

- Standing Committee chairs reported receiving support from the Diocesan council in the form of mentoring and directives. Little training was received from higher levels during this past year.
- Spiritual Development chairs would like executive training on all positions with the Diocesan Council

# **Recruit Members and Maintain Membership**

- There have been 7 new members under the age of 40 in the 19 councils reporting.
- More than 50% of councils do member renewals online which is more than last year.
- Members were recognized by pin presentations, lunches, teas, and use of verbal recognition.
- New members were engaged by welcoming them, inviting them to events, asking them to participate and offering workshops.
- Members were included in decisions for annual plans and goals.
- Gifted an RCIA candidate with a membership.

#### **Leadership Development**

- Some councils reported some participation in retreat days.
- Our Diocesan and Provincial as well as our National Conventions were cancelled due to Covid19.
- All councils reported having members serving on either diocesan council, and/or provincial council.

#### **League Resource Material**

- Councils reported purchasing service pins, prayers cards and welcome brochures.
- Mass cards were sent.

# **Annual Reports**

- 80% of councils use the guidelines to assist in completing their reports.
- Annual reports are usually done by getting together as a group but due to restrictions most were done at home.

# **Life Membership**

- Some councils have life members living in their area and find them a great benefit to their council.
- Life members are a wealth of knowledge and assist in reports and election protocol.
- Life members act as mentors and are always willing to help and facilitate workshops.

#### Additional

- During covid councils kept lines of communication open via emails and phone calls.
- There were opportunities for communal prayer.
- One council was able to provide an outdoor honor guard for a deceased member of 62 years at her funeral.
- Lines of communication were kept open with phone calls and emails and posts in the online church bulletin as well as masked meetings and zoom meetings.
- Some councils continued to support their regular charities.
- Due to covid activities in the parishes were limited in 2021 with most members not meeting in person.
- The most necessary business was conducted by the executive.
- Usually, a large number of members participate in fundraisers while fewer attended meetings.

- Emails were sent providing information to be shared at the diocesan, provincial and national levels.
- Ecards were sent to life members throughout the country as we celebrated together the joys and sorrows of life.
- Kingston Life Members continue to mentor members at the parish and diocesan levels.
- Life Members have stepped into the role as parish presidents in order to continue the League in their parish. They have served as facilitators and advisors, especially during the election process and compilation of the Kingston Diocesan 10-year history book.
- One member serves on the sub-committee of Spiritual Development at the national level and Life Member, Anne Madden is completing her term as Ontario Past-President/Historian.
- Parishes are encouraged to keep in touch with their life members and utilize their knowledge.
- Parishes would also benefit from asking life members, especially those that may be homebound, to be prayer partners for the future of The Catholic Women's League.

#### **Christian Family Life Standing Committee Report**

2021

Parishes Reporting: 15 / 43

#### **Marriage and Family**

- One council planned an event to recognize the Year "Amoris Laetitia Family." Pope Francis proclaimed March 19, 2021 to June 26, 2022.
- Three councils indicated that they supported victims of domestic abuse via: supporting and donating to local women's shelters; Interval House, referral and support to access local programs;
- Provided marriage preparation courses;
- One council had members who attended workshops or seminars on the topic of family life.

#### **Sanctity of Life**

- Two councils held memberships in pro-life organizations;
- Others participated in: March for life, pro-life masses, life chain, pro-life walks and vigils, national week for life and family events, pro-life vigils and 40 days for life;
- Made donations to: Birthright, Campaign Life Coalition, Euthanasia Prevention Coalition, local pro-life organizations, Pregnancy and Family Support Services, Priests for Life;
- Two councils indicated that they have copies of the current pro-life brochure available in their church vestibule;
- Three councils have met with pro-life legislators and seven have written letters to inform legislators of CWL resolutions on abortion and euthanasia.
- Ten councils have regularly prayed for the protection of life.

#### **Ministry to Youth**

- Three Councils participated in programs for Youth and encouraged young people to share their gifts in ministry;
- Many sponsored youth events or youth ministers in their parish community such as: Catholic Christian Outreach, World Youth Day and Sunday school.

#### **Ministry to the Disabled**

- Two councils organized or participated in support groups and respite for caregivers;
- Reached out to the disabled by bringing communion, sending cards, visiting, praying, including them in CWL events, providing transportation.

#### **Ministry to Seniors**

 Councils called, visited, involved them in CWL events, brought communion, provided transportation, gifted them with membership, sent cards of encouragement, prayed with them, organized social events, invited newly-retired women to join, shared a meal, initiated social programs and celebrations, involved them in intercessory prayer.

#### **Ministry to Widowed**

 Councils sent cards of condolence, visited and called; arranged memorial services and/or funeral lunches; provided prayer and support after the death of the spouse; encouraged participation in programs offered by the parish; ensured there is a bereavement program in the parish.

#### **Ministry to Separated & Divorced**

Councils supported them by lending an ear and through prayer.

#### **Vocations**

- Sent spiritual bouquets, participated in prayers for vocations, adopted or supported seminarians;
- Encouraged families to invite priests and religious into their home;
- Hosted luncheons for priests and religious;
- Viewed World Day of Prayer for Vocations website for resources
- Attended the Ordination of a local Deacon on-line.
- Circulated a cross in a prayer box. Each family had it for 2 week and prayed daily for priests and vocation to religious life.

# **Dignity and Rights of Persons**

- Volunteered with minority groups (those incarcerated, suffering from domestic violence, homelessness, poverty and racism)
- Invited Indigenous women to be guest speakers

 Increased awareness of the laws against human trafficking through sharing and discussing books and general intercessions at Mass

#### **Social and Economic Justice**

- Volunteer, prayerful, and financial support to local organizations (affordable housing, antipoverty, after school programs, clothing drives, drop-in centers, emergency shelters, food banks and soup kitchens)
- Councils celebrated National Indigenous Peoples Day on June 21, 2021, by participating in virtual masses
- Recognized the first National Day for Truth and Reconciliation on September 30, 2021, by reading/sharing articles, prayer services, offered masses, wore orange shirts, and displayed We Matter signs

#### Refugees, Immigration and Citizenship

- Improved knowledge of issues facing immigrants and refugees (availability of employment services, English language courses, financial assistance for food and rent)
- Participated in Remembrance Day services; supported the Royal Canadian Legion poppy campaign; wore red on Fridays to support Canadian troops
- Celebrated the CWL Day of Prayer for Christian sisters and brothers in the Holy Land and Middle East on September 21, 2021 (the World Day of Peace) by participating in mass and Mary's Way of the Cross, and printing and distributing prayers at mass in advance

#### **Canadian Catholic Organization for Development & Peace**

 Participated in the League's program of donating 1% of the price of luxury items purchased during this year to CCODP

#### **Developing Countries**

- Supported organizations that focus solely on developing countries (Chalice, World Vision, Buy-A-Net Malaria Prevention Group, Habitat for Humanity, Canadian Red Cross, Holy Childhood Association, Save a Family Plan, Samaritans Purse, Doctors without Borders)
- Improved awareness of conditions and implications of child labour, trade laws, and economic difficulties within developing countries, and criticized structures that put profits before people

#### **Education and Health Standing Committee Report**

#### **Catholic Education**

- The majority of councils are aware of the Catholic teachings in our schools with regards to family life. Needs of the schools were identified and addressed as follows:
- provided school supplies
- donated books to Catholic elementary school with emphasis on Christian values
- taught material for preparation for First Communion and Confirmation

- approximately half of councils contributed to scholarships and bursaries to elementary and secondary school students
- some councils support the Bernard F. Pappin Bursary Memorial Fund
- a number of parishes contributed to Catholic Missions in Canada.

#### **Health and Wellness (Sickness/Disease)**

- A majority of councils were unable to support national organizations that focus on the health and wellness of Canadians (due to not having meetings). Those that were able to though, supported: CNIB. Canadian Cancer Society, Heart and Stroke Foundation, Autism Canada, Canadian Diabetes Association, Canadian Mental Health Association and Mater Care.
- Members were encouraged to read and become knowledgeable about Covid 19, so that they
  can understand ways they can prevent and protect themselves against this virus and members
  were encouraged to get vaccinated
- All councils participated in some form of service regarding '12 Hours of Prayer for Palliative Care'. Letter-writing campaigns were undertaken on palliative care for all Canadians, on Bill C-7 (MAID)
- Councils continued to do wellness checks on their members during these periods of isolation
- Councils held virtual speakers through Zoom on MAiD, Dementia and Spirituality and Mental Health Life Coaching

#### **Literacy and Continuing Education**

- A minority of councils are aware of scholarships and bursaries that are available to women for their education
- A large majority have contributed to the Coady International Institute this year

#### **Environment**

- Fifty five per cent of councils participated in 'Care for Our Common Home' initiatives including
  plastics and waste cleanups. Commitments were made towards reducing single-use straws and
  plastic bags, green bins for organic waste, composting and reduction of paper use. One council
  participated in Earth Day by focusing on the awareness of the impact of reduction of use of
  lighting. One council held a Zoom Prayer Service on Water Quality in Canada.
- Some councils planted a tree to commemorate the 100<sup>th</sup> anniversary of the League in Canada

#### Genetics

• One councils subscribe to the Canadian Catholic Bioethics Institute newsletter and others committed to learning more.

 Promoting faith-oriented programs such as National Day for Truth and Reconciliation; world communications day; The Catholic Register; Mass for Shut-ins plus salt and light daily mass.

Shared League Mass on April 26 in honour of "The Feast of Our Lady of Good Council".

#### **Media: to Promote the League**

About 50% of council's have encouraged members to visit the CWL on Facebook or Twitter.
 88% of council's have encouraged members to use cwl.ca. Most councils use church bulletin inserts or bulletin boards at church.

#### **Media: Evaluation and Promotion of Good Content**

• It has been a difficult year and less than 10% of councils have encouraged members to monitor media content.

#### **Media: Newsletter and Bulletins**

- Have used local media and parish websites for submitting material for publication or sent thank you after events or invitation to attend events
- Organized telephone calls to members or by email

#### **Pornography**

- The diocesan council has found due to covid there was no distribution of Pornography Hurts, they have not promoted the Over 18 documentary, or film Red Light Green light. Some have encouraged members to become more involved. 25% of council's have encouraged members to educate themselves and their families on safe, wise and responsible Internet use.
- 42% of council's have shared with their members the strategic planning information 25% recite the Renewal Prayer found on the National website.

# Serve in a Consultative Capacity

• It is interesting that again this year the majority of past presidents in our diocese have been members for more than 20 years and have been in this executive position previously. They obviously are a source of love, strength and support for the league. These past presidents show their dedication through their attendance at events and meetings at least most of the time. Although they are not often called upon to give advice, they mostly agreed that their president feel supported and that they, as past presidents are there to answer questions and give assistance when needed.

# Be Responsible for Archives and History

• The majority of past presidents reported that they were responsible for the council archives.

- Most indicate they are stored in a CWL cupboard or space. Most were aware of the whereabouts of their council charter.
- Ladies reported storage of documents most often in filing cabinets. Most items are kept indefinitely or for 8 9 years. Some councils reported not keeping a Book of Life. Perhaps this might be a project worthy of attention.
- Most past presidents reported that their council reviewed their archives as needed. 50% reported keeping a history book. Photo albums are a popular way of maintaining history and some councils are now storing pictures and documents on sticks.
- There has been much variation on the period of time that minutes and reports have been kept by councils. Some past presidents reported they were kept indefinitely, while some others reported they have been kept for a much briefer period of time.

# Facilitate the Study and Implementation of the Constitution & Bylaws 2013 (revised)

- Councils have copies of Constitution and Bylaws, the National Policy and Procedure and the Diocesan Policy and Procedure. These documents were sometimes consulted, but not on a regular basis. 9 of the 17 councils reporting, said they have their own manual of policy and procedure. Of the other 8 councils, only one said they would like to work on a new P&P in the new year. Councils were more likely to seek advice from their spiritual advisor and from members of the diocesan council. Other levels were not often approached, but advice and information were occasionally sought from National office and Life Members.
- Other duties taken on by several past presidents are as follows: nomination and election committee (43%); organizing social events (36%); sharing information from national and provincial websites (29%), filling in a vacant position (29%) and representing the council at convention (29%).
- Half of those responding are at least usually satisfied with communication they receive from National Council, Provincial Council and Diocesan Council. They report that communication from diocesan Council is always relevant and that it is usually relevant coming from the provincial and national levels as well and it is concise and time appropriate for action or response.
- Half of those responding have supported the implementation of the envisioned future of the League through Planning Strategically.

# **Diocesan Highlights**

Past presidents commented on their abilities to carry on with projects that have been very
close to their hearts during this difficult year. They commented that prayer and intervention
of the Holy Spirit has been and continues to be essential to the work of the League. Some
councils have already celebrated or are preparing to celebrate 100 year anniversaries by
planting a tree, placing a granite bench in a parish cemetery. Past presidents report other
challenges such as: Members who do not agree on the direction in which their council is being
directed; aging membership; use of technology in order to meet; keeping on top of
information and directives.

#### Recommendations

- I would encourage councils without their own Policy and Procedure, to gather a few ladies together and build one. Perhaps councils might introduce a book of life to their council.
- Past presidents should follow the Strategically Planning timeline and keep their council informed of goals and strategies that are being implemented.

- I applaud past presidents who stay involved in their parish councils as mentors and historians. As I mentioned, many of us have over 20 years' experience in and love for the League. We must remain in a supportive role and applaud new ideas and ways of facilitating events.
- I would also strongly encourage past presidents to write a report of highlights of her term as president. This can be kept as the history for her term and will be appreciated by future councils.

## **Chairperson's Report**

- As past president of diocesan, I have prepared directives and forwarded them to parish and provincial counterparts.
- I have attended and reported at executive meetings. I have been attending other meetings when asked. I have been busy working on collecting and organizing our recent history.
- I am also organizing and preparing for the 2022 Diocesan election.

# **Recording Secretary Report**

# **Duties of the Recording Secretary**

- 52% (11) held the position of Recording Secretary only, 38% (8) held both the position of secretary and corresponding secretary. Two councils had neither and the positions were covered by the president or the Organization chair.
- Of the 21 recording secretaries, who filed an on-line report, only 8 were elected, 13 were appointed.
- The survey then asked them to report on the following: (95%) take minutes, but only 12 were signing officers, 126 knew where their charter was located, and 86% maintained a list of their executive officers with contact information.
- Nine of those who responded were aware that their council had a motions book, 10 replied that their council did not and only 2 were unaware if one existed.
- Asked if they received written reports from the executive 10 replied yes, 7 replied sometimes and 4 replied they did not receive written reports from the executive.
- When it came to knowledge of the *Handbook for Secretaries* only 15 were aware of such a handbook.
- Only 12 were aware of the existence of the CWL Personal Letter Writing Guide, 6 didn't know and 3 said no

# **Challenges**

- The overwhelming challenge in 2021 was again the COVID-19 pandemic.
- One council was unable to hold meetings, while another council was only able to hold one
  meeting, outdoors during the summer. Another council, unable to meet in person,
  communicated by updating their website, sending emails.
- Another secretary felt her biggest challenge, as with those of her Council's members, was feeling safe to attend in person meetings.
- Most saw that their biggest challenge was keeping members informed. Most used email, telephone, mailbox drop-offs and social media.

 Some Councils met this challenge by utilizing technology such as Zoom, emails, and quarterly newsletters. It is difficult to hold virtual meetings when dealing with an older demographic that is not into technology.

#### **Communications Satisfaction Survey**

• This year the National Council asked respondents to rate communications they receive from National, Provincial, Diocesan and Regional Councils. They were asked to rate not only how satisfied they were with communications from the 4 levels, but also to rate how relevant, and if the communications were clear and concise. They were also asked how often they received duplicate communications, and did they feel that, when asked/invited to respond to a particular communique, that they were given enough time to complete the task. Responses as to the survey varied. 50% or half said that communications were clear and concise; 43% said that they never received duplicate communications and 12 out of the 20 (60%) felt that they usually had enough time to respond to a request or invite. 30% felt communications were relevant to their council and finally Provincial council's communications received the highest (45%) ranking for satisfactory communiques.

#### Recommendations

• The main duties of a recording secretary can be found in the following response one secretary gave to the question "What was your biggest challenge as secretary and how did you address it?" "As a number of Executive meetings were conducted via zoom over the past year, ensuring an accurate record of the motions made and/or issues discussed was the biggest challenge; ensuring minutes are translated immediately and in consultation with the President, when necessary, was the most effective way to ensure accurate reporting". Without in person meetings League members have felt further isolated during the pandemic. Corresponding and Recording Secretaries found ways to alleviate some of the isolationism through emails, personal phone calls. They kept members informed.

#### **Corresponding Secretary Report**

- 38% of councils report corresponding and reporting secretaries do both. Only 0% are corresponding secretaries.
- 38% were elected and 62% were appointed.
- 86% maintain a list of executives with contact information.
- Notification of meetings was made by recording secretary.
- Send out cards such as anniversary, birthday and sympathy.
- Many members elderly and ill appreciated and expressed their gratitude upon receiving cards and prayers from the council, especially those receiving sympathy cards.
- Meetings were held via Zoom and sent newsletters to members

#### **Challenges**

- Biggest challenge was Covid-19.
- Do not have full executive.

- Unable to hold meetings but kept in contact with members by updating website and sent emails.
- Members felt unsafe to attend meeting; meeting not held due to members not being vaccinated
- Inability to meet face to face or by Zoom due to rural challenges with Internet.

- 4. **National Council:** shall be composed of its officers, presidents of provincial councils, honorary life members, life members, and provincial and diocesan delegates accredited to the national convention

#### **Objects**

The objects of the League shall be to unite Catholic Women of Canada:


- 1. to achieve individual and collective spiritual development

- 5. to cooperate at all levels with other organizations where and in whatever
- 6. manner the council concerned agrees is necessary or desirable to accomplish the objects of the League
- 7. to maintain liaison with pastoral councils in accordance with the Code of Canon Law politically non-partisan
